Comment	UoA support the RN competencies however, we suggest the name is changed away from the term <b>competencies</b> . We suggest Registered Nurse Standards for Practice. Suggest Using standard descriptors for each detailed component rather than numbered competencies to move away from the need to demonstrate each individual competency but provide a case study which demonstrates the meaning of the Pou. UoA also supports the opportunity for some merging and collapsing of the numbered competencies to simplify the tool and reduce repetition.

<b>Question 17.</b> What would you strengthen, change, or add to Pou One?	UoA support the scope and focus of Pou One and suggest it is used consistently across both EN and RN. Decide on one name, Te Tiriti O Waitangi would be good across all Scopes of Practice EN, RN and NP. Pou One: <i>This pou requires evidence of critical</i> <i>consciousness and nursing practice which gives effect to Te</i> <i>Tiriti o Waitangi and human rights advocacy. Nurses have an</i> <i>ethical responsibility to lead in the elimination of health</i> <i>inequities and the achievement of a health care system that</i> <i>delivers appropriate and equitable healthcare for all.</i> Comment: This pou does not make the bicultural nature of the

	TOW explicit. It has a very general approach to TOW including health inequities. It would be better to make clear that in terms of the TOW the relationship is between Maaori and the Crown and the inequity here is specific to Maaori and Maaori health. Competencies 1.2 – 1.3 are therefore too general and should focus on the relationship with Maaori
Pou Two: Kawa W	hakaruruhau and Cultural Safety

<b>Question 19.</b> What would you strengthen, change, or add to Pou Two?	UoA believe the name and content of this Pou should be the same across both EN and RN and would support either Kawa Whakaruruhau and Cultural safety or just cultural safety as a title for this Pou. This domain has to do with cultural safety and makes explicit that the nurse's values, biases and beliefs are important and would be strengthen with some recognise that patients/clients have a right to be cared for in a culturally safe way which is really determined by them. Competency 2.3 could rather go to Pou One.
